**ARTICLES OF INCORPORATION**

**ARTICLE I - NAME**

The name of the Corporation (the "Corporation") is **BSH Channel Inc.**

**ARTICLE II - ADDRESS**

The principal address and mailing address of the Corporation is:

**ARTICLE III - DURATION**

The Corporation shall have perpetual existence.

**ARTICLE IV - PURPOSE**

The Corporation may engage in any activity or business permitted under the laws of the United States of America and of the State of Florida.

**ARTICLE V - CAPITAL STOCK**

The Corporation is authorized to issue 10,000 shares of \$1.00 par value common stock, which shall be designated "Common Shares." The rights, preferences and privileges of the Class A and Class B shall be identical, except that the Class B shall not be entitled to vote on any matter required to be approved by, or submitted for approval of, shareholders.


