ARTICLE XII


The private property of the stockholders shall not be subject the payment of the Corporate debts to any extent whatever. The Corporate shall have a first lien on the shares


of its stockholders and upon the dividends due them for any indebtedness of such stockholders to the Corporation.

ARTICLE XIII

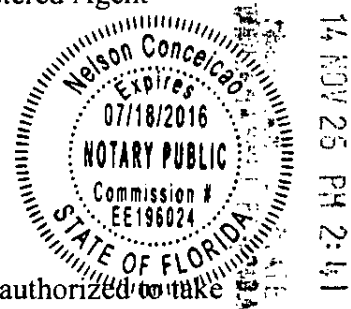
