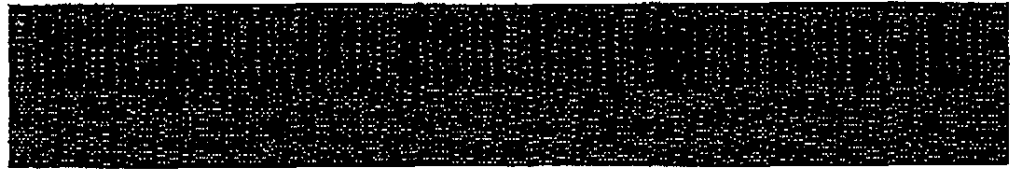

The undersigned subscribers to these articles of incorporation hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of this corporation is HARDLUX CORP.

GENERAL NATURE OF BUSINESS

These articles of incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors,






