I

BUSINESS:

This Corporation through its Officers and Employees shall be authorized to engage in every aspect and phase of the sale, rental and management of real estate in Florida; to engage in any activities which will facilitate and promote its real estate practice through its Officers and Employees; and to invest and reinvest its funds in real estate, mortgages, stocks, bonds any other type of investments within the meaning of Florida statute 621.08; and to purchase and own real
