**ARTICLES OF INCORPORATION
OF
SKIN ASSOCIATES OF SOUTH FLORIDA, P.A.**

Pursuant to the provisions of the Florida Business Corporation Act (Chapter 607, Florida Statutes) and the Professional Service Corporation and Limited Liability Company Act (Chapter 621, Florida Statutes), the undersigned does hereby execute and submit for filing with the Florida Department of State these Articles of Incorporation as follows:

ARTICLE I - NAME

The name of the corporation is Skin Associates of South Florida, P.A.

ARTICLE II - ADDRESS

The principal office address and mailing address of the corporation is 4425 Ponce de Leon Blvd., Suite 200, Coral Gables, Florida 33146.

ARTICLE III - CAPITAL STOCK

The corporation is authorized to issue 1,000 shares of common stock, par value \$0.01 per share.

ARTICLE IV - REGISTERED OFFICE AND REGISTERED AGENT


ARTICLE VI - NATURE OF BUSINESS

The general nature of the business to be transacted by the corporation shall be to engage in every aspect of the practice of medicine. The professional services involved in the corporation's practice of medicine may be rendered only through its officer, employees and agents who are duly authorized and licensed to practice medicine in the State of Florida. The corporation shall not engage in any business other than the profession of medicine; provided, however, that the corporation may invest its funds in real estate, mortgages, stock, bonds or other types of investments and may own real and personal property necessary for the rendering of the professional services authorized hereby.

ARTICLE VII - RESTRICTION ON TRANSFER OF SHARES

No shareholder of the corporation may sell or transfer any of its shares of stock in the corporation, except to another person who is then duly authorized and licensed to practice medicine in the State of Florida.

IN WITNESS WHEREOF, the undersigned has executed these Articles of Incorporation as of this 21 day of April, 2015.




