The maximum number of shares that this corporation is to have outstanding at any one time is One thousand (1,000) shares of common stock, having a nominal or par value of One Dollar (\$1.00) per share. The consideration to be paid for each share shall be fixed by the board of directors but in no event shall be less than \$1.00.

**ARTICLE V.**

**TERM**

This corporation shall commence existence on the date of the filing of these Articles of Incorporation and shall have perpetual existence.

**ARTICLE VI.**

**REGISTERED AGENT AND REGISTERED OFFICE**

The Registered Agent for this corporation shall be Juan Carlos Ojeda and the Registered Office shall be located at 31 SE 5 Street, Suite 2002, Miami, FL 33131 or at such other place as the Board of Directors shall from time to time direct, with appropriate notice being given to the Secretary of State in accordance with the law.

This corporation shall have not less than one nor more than six directors, as set forth in the By-Laws. **ARTICLE IX.**

**INSPECTION OF BOOKS AND RECORDS**

The corporation shall from time to time determine whether and to what extent and at what times and places and under what conditions and regulations the accounts and books of the corporation (other than the stock book) or any of them shall be open to inspection of shareholders; and no shareholder shall have the right of inspecting and accounts, book or document of this corporation except

as conferred by statute, unless authorized by a resolution of the shareholders or the board of directors.

##### **TELEPHONE MEETING AUTHORIZED**



**AMENDMENT**


These Articles of Incorporation may be amended in the manner and with the vote provided by law.
