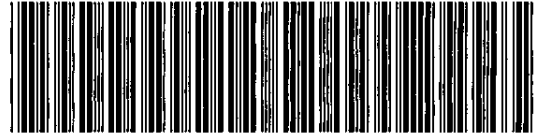

1. Introduction. Rhonda Hernandez, being duly sworn, deposes and says:


