**ARTICLES OF INCORPORATION
OF

The undersigned incorporator hereby makes, subscribes, acknowledges and files with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

**ARTICLE I
Name**

The name of this corporation is **ADDISON LONG BAYOU DEVELOPMENT, INC.** Its principal place of business and mailing address is 237 South Westmonte Drive, Suite 140, Altamonte Springs, Florida 32714.

**ARTICLE II
Existence of Corporation**

This corporation shall begin existence on the date of filing of these Articles with the Secretary of State, Division of Corporations for the State of Florida and shall have perpetual existence.

**ARTICLE III
Purposes**

The corporation may engage in the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Florida.

**ARTICLE IV
Authorized Shares of Capital Stock**

The total number of shares of capital stock authorized to be issued by the corporation shall be 10,000 shares of common stock having a par value of \$.01 per share. All common stock when issued shall be paid for and shall be non-assessable.

This corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.


