ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF COLLINS INTERNATIONAL SERVICE COMPANY

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:
