The private property of the shareholders shall not be subject to payment of the corporate debts to any extent.

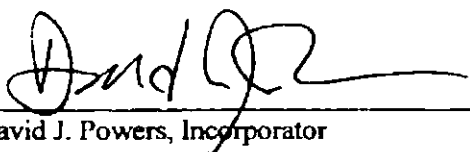
ARTICLE X.
