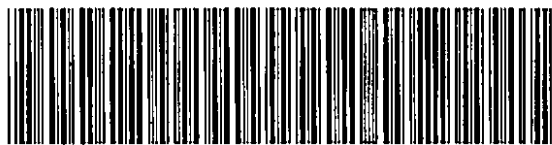



**ACTION BY WRITTEN CONSENT  
OF THE BOARD OF DIRECTORS  
OF

The undersigned, being the members of the board of directors of Equity Design Collaborative, Inc., a Florida corporation (the "**Corporation**"), named in the articles of incorporation, do hereby take the following action pursuant to Sections 607.821, 607.1401 and 607.1403, Florida Statutes, in lieu of holding a meeting of the board of directors of the Corporation, to have the same effect as action taken at a duly called meeting of the board of directors at which all directors were present:

1. The Corporation has not issued any shares of capital stock. The incorporators have elected to terminate their business relationship concerning the Corporation.
2. Therefore, the Corporation shall be dissolved, cease all further business, and liquidate its assets. It shall pay its creditors from and to the extent of such assets such amounts as may be validly outstanding and due, when and as they become due, if any. Any remaining proceeds shall be distributed one-half each to Christine Ortiz and Caroline Hill.
3. The Articles of Dissolution for the Corporation prepared by counsel are hereby approved. The Corporation shall promptly file the Articles of Dissolution with the Secretary of State of Florida and pay the filing fee therefore. The effective date of the dissolution of the Company shall be the filing date of the Articles of Dissolution.
4. The Directors of the Corporation be, and hereby are, directed and authorized to take such actions as they, in their sole discretion, deem appropriate to carry out the actions and intentions of this Action by Written Consent.
