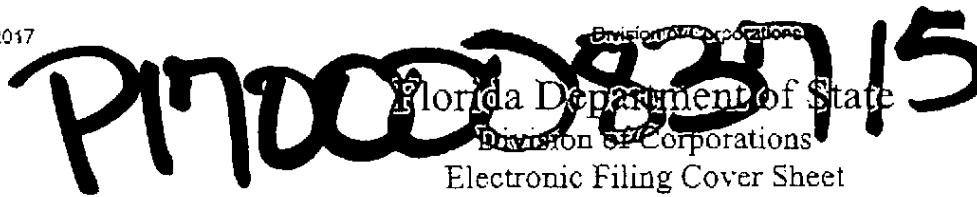

The undersigned, for the purpose of restating and amending the articles of incorporation for Kristal Corp., formed pursuant to the Florida Corporation Act, F.S. Chapter 607.1006, on October 17, 2017, hereby make, acknowledge, and file these Restated and Amended Articles of Incorporation. This Restated and Amended Articles of Incorporation was adopted by the Board of Directors pursuant to Section 607.1007(4)(a).

Article I

Name

The name of this corporation is KRISTAL CORP.

Article II

Principal Office Address

The principal office and mailing address of the Corporation is located at: 100 S.E. 2nd Street, Suite #3800, Miami, FL 33131.

Article III

Nature of Business

This Corporation is being formed for the following purposes:

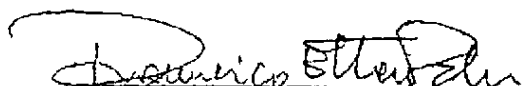

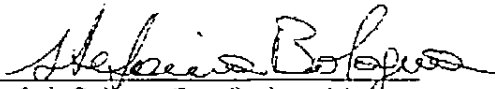
