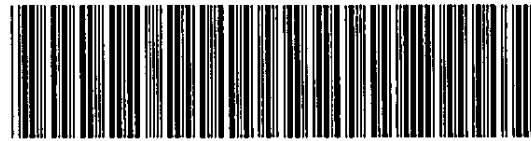

ARTICLES OF INCORPORATION  
OF  
JAMES D'AURIA, P.A.

The undersigned hereby establishes the following for the purpose of becoming a Professional Service Corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida providing for the formation, liability, rights, privileges and immunities of a Corporation for profit.

ARTICLE I  
Name of Corporation

The name of this Corporation shall be JAMES D'AURIA, P.A. (the "Corporation").

ARTICLE II  
Mailing Address and Principal Place of Business

The mailing address and principal place of business of the Corporation is 2580 S. Ocean Blvd., #2-A-7, Palm Beach, FL 33480.

ARTICLE III  
Purpose

This Corporation is organized for the following purposes:

- (a) To provide architectural services to the general public by licensed architect.
- (b) To have and to exercise all the powers now or hereafter conferred by the laws of the State of Florida upon professional service corporations organized pursuant to the laws under which the Corporation is organized and any and all acts amendatory thereof and supplemental thereto.
- (c) For the purpose of transacting any or all lawful business.
- (d) To do any and everything pertinent to the above.
