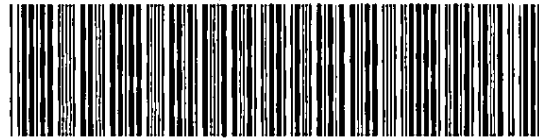




ARTICLE XII


