#### <u>ARTICLE 1</u>

The name of the corporation is MEGAN ELWELL HOLDINGS, INC.

If the Florida Business Corporation Act is amended to further limit or eliminate liability of a director, then a director of the corporation shall not be liable for any such act or omission to the fullest extent permitted by the Florida Business Corporation Act, as so amended.
