ARTICLE I - NAME

The name of this corporation is: LOGICA LATAM INC.

ARTICLE II - DURATION

This corporation is to exist perpetually. It shall commence its existence at the time of filing these Articles of Incorporation.

ARTICLE III - PURPOSE

ARTICLE IX - INDEMNIFICATION

ARTICLE XIII - POWERS


This corporation shall have all powers necessary or convenient to affect its purposes as enumerated in the Florida General Corporation Act.

All corporate powers shall be executed by under the authority of, and the business and affairs of this corporation shall be managed under the direction of the board of directors.


ARTICLE XIV - AMENDMENT


