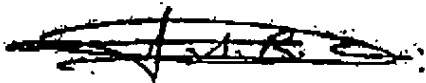
ARTICLE XI - INDEMNIFICATION

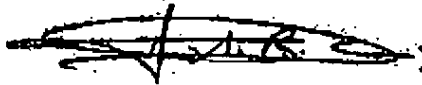
