OF

The undersigned, acting as incorporator of Linares Ladrón de Guevara, Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is Linares Ladrón de Guevara, Inc. (the "Corporation").


ARTICLE X. AMENDMENTS


