ARTICLES OF INCORPORATION
OF
SENSOR AMERICA, INC.

The undersigned, acting as the Incorporator of Sensor America, Inc., a Florida corporation (the "Corporation"), pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for the Corporation:

ARTICLE I - NAME/ADDRESS

The name of the Corporation is Sensor America, Inc. The street address of the initial principal office of the Corporation and mailing address shall be Quatro House, School Lane, Lytham, Lancashire, FY8 5NL, UK.

ARTICLE II - CORPORATE EXISTENCE

The Corporation will exist commencing on the date of filing these Articles of Incorporation with the Florida Department of State.

ARTICLE III - DURATION

The Corporation shall exist perpetually.

ARTICLE IV - PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful businesses which corporations may be incorporated under Chapter 607, Florida Statutes.
