**ARTICLES OF INCORPORATION
OF
EMERALD COAST REGEN, P.A.**

In compliance with the requirements of F.S. Chapter 607 and 621, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is: Emerald Coast Regen, P.A.

ARTICLE II

The existence of the Corporation shall begin on the date of filing of these Articles of Incorporation.

ARTICLE III

The street address of the principal office of the Corporation is: 1008 Jenks Avenue Panama City, Florida 32401.

ARTICLE IV

The specific purpose for which the Corporation is organized is to render chiropractic services.




