The name and street address of the incorporator is Antonio Diaz, 2121 SW 3rd Avenue, Suite 500, Miami, FL 33129.

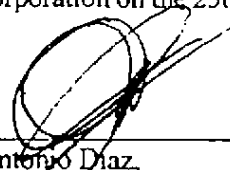
ARTICLE IX. BYLAWS

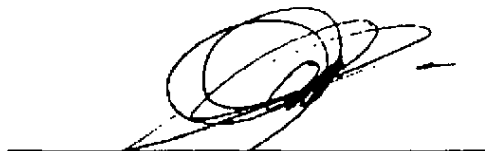
