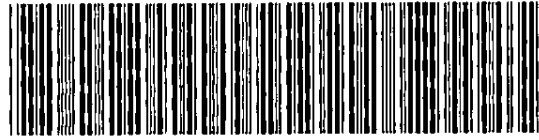

**ARTICLES OF INCORPORATION  
OF  
TLD-SOUTHEAST, INC.**

The undersigned, acting as the incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I  
Name of Corporation**

The name of the corporation is TLD-Southeast, Inc.

**ARTICLE II  
Commencement And Duration of  
Corporate Existence**

Corporate existence shall commence on December 1, 2020 and shall exist perpetually thereafter until dissolved according to law.

**ARTICLE III  
Corporate Purpose**

This corporation is organized for the purpose of transacting any and all lawful business permitted under the laws of the United States and the State of Florida.

**ARTICLE IV  
Capital Stock**

The corporation shall have authority to issue one hundred thousand (100,000) shares of Capital Stock with no par value. The shares of the corporation are not to be divided into classes.

The power to adopt, alter, amend or repeal bylaws shall be vested in the board of directors and the shareholders, but the board of directors may not alter, amend or repeal any bylaws adopted by the shareholders if the shareholders provide that the bylaws shall not be altered, amended or repealed by the board of directors.
