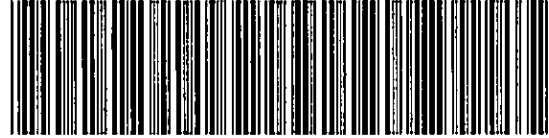

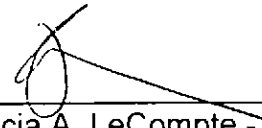

**Article II: Purpose**

This will include any and all lawful activities or functions, and to carry on any other lawful activities in connection with or incidental to the foregoing, as the Officers in their discretion shall determine.

The corporate name will be filed as: LeCompte Consulting Inc. A fictitious name will be filed to do business as: LeCompte College Prep.

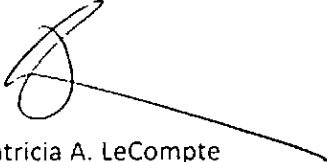
The corporation shall be registered as an S Corp.
