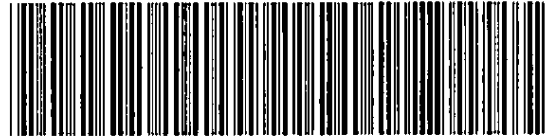

**ARTICLE I**

The name of the corporation is The Credit Pros International Corporation (Florida) (hereinafter called the "Corporation").

**ARTICLE II**

**ARTICLE VI**

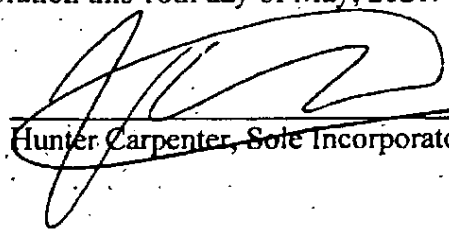
