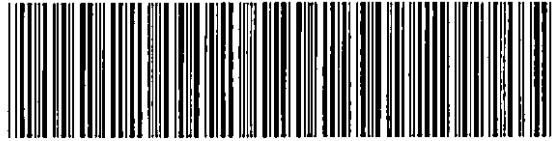

Article IV - "Authorized Shares and Shareholders" shall be amended and restated in its entirety as follows:
