I am writing in response to a letter from your office (copy enclosed for your reference) dated June 20, 2002 rejecting our filing of the Uniform Business Report for Advanta Life Insurance Company. The reason for rejection provided in the letter was that the late filing fee was due and had not been enclosed. By way of background, four Advanta entities did not receive business reports by mail from the department. When we discovered that we had not received the reports, Carole Moffo of our office contacted your department for instructions. She was advised to obtain the forms from your website and submit them with the normal (no late fee) filing fee of \$150.00 each. Ms. Moffo submitted reports for the other two Advanta entities for which she was responsible. Under cover of a June 12, 2002 letter (copy enclosed) I submitted the Uniform Business Reports for Advanta Life Insurance Company and Advanta Insurance Company, along with Advanta checks numbered 006139 and 005115 each in the amount of \$150.00 in payment of the filing fees for the two entities.
