The indemnification is not exclusive of any other rights to which those indemnified may be entitled under any bylaw, agreement, the vote of shareholders or disinterested directors or otherwise. The indemnification continues as to a person who has ceased to be a director, officer, employee or agent, and inures to the benefit of the heirs, personal representatives of such a person, and an adjudication of liability does not affect the right to indemnification for those indemnified.


**Article 12 - Bylaws**




