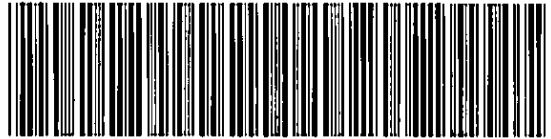



ARTICLE I: NAME
