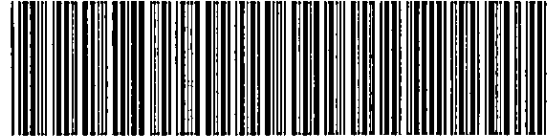

ARTICLES OF INCORPORATION
OF

The initial shareholders of the company are MURAT IYRIBOZ holding 500 shares and TOLGA AYDINOL holding 500 shares.

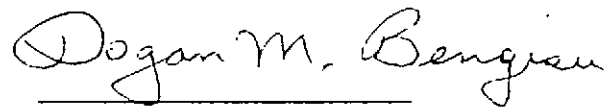

ARTICLE XI - BYLAWS

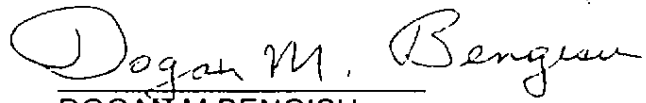
The power to adopt, alter, amend or repeal the bylaws of the corporation shall be vested in the Board of Directors.
