**ARTICLE I. NAME**

The name of this Corporation shall be RAY'S AUTO CLINIC, INC.

**ARTICLE II. MAILING ADDRESS & PRINCIPAL OFFICE**

The mailing address and principal place of business of the Corporation is 41524 11<sup>th</sup> Avenue East, Myakka City, Florida 34251.

**ARTICLE III. COMMENCEMENT & DURATION**

The commencement of this Corporation's existence shall be at the time of signing of these Articles of Incorporation. This Corporation's duration shall be perpetual.

**ARTICLE IV. PURPOSE**

The general purposes for which the corporation is organized are the following:

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purposes of the corporation or necessary or desirable in order to accomplish them.

This right shall be deemed waived by any shareholder who does not exercise it and pay for the shares preempted within thirty (30) days of receipt of a notice in writing from the Corporation, stating the prices, terms and conditions of the issue of shares, and inviting him to exercise his preemptive rights. This right may also be waived by affirmative written waiver submitted by the shareholder to the Corporation within thirty (30) days of receipt of notice from the Corporation.

ARTICLE X. AMENDMENT OF ARTICLES

The power to adopt, alter, amend, or repeal the Articles Of Incorporation of this Corporation shall be vested in the shareholders by a majority vote of such shareholders.




