The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

**ARTICLE I - NAME**

The name of the Corporation is CENTER FOR PAIN AND MEDICAL REHAB, P.A., (hereinafter, "Corporation").

**ARTICLE II - PURPOSE**

The Corporation's purpose is:

1.
