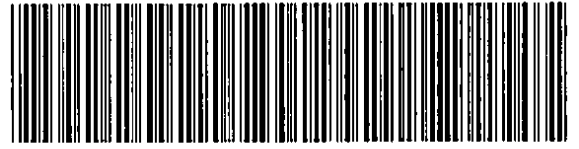

However, an LLC cannot act as manager for a corporation and therefore IMH 4 LLC needs to be removed.

The correct title for a corporation is "directors" not "managers", therefore the inaccuracy needs to be corrected.

There is no need to appoint/remove directors but only to correct their roles and remove the LLC.
