## AFFIDAVIT IN SUPPORT OF DISSOLUTION OF S. BOWER, INC. DUE TO FRAUD

- I, Shahin Torkian, attest to the following, under the penalties of perjury:
- 1. I am the owner and member of S. Bower Inc., a New York corporation with a principal place of business located at 3809 43<sup>rd</sup> Avenue, 1<sup>st</sup> Floor, Long Island City, New York 11101. See New York incorporation documents attached.
- 2. I submit this Affidavit in support of the dissolution of S. Bower, Inc. fraudulently incorporated in Florida on or about October 26, 2023 under Document No. P23000076115.
- 3. On or about November 1, 2023, S. Bower, Inc., received a call at its New York headquarters from Truist Bank asking if a government check for \$83,831.00 was valid and could be deposited into a new account that S. Bower, Inc. supposedly opened at a Truist branch in Florida. A copy of the check is attached hereto.
- 4. We informed Truist bank that we are a New York based company and we did not open any bank accounts in Florida.
  - 5. Truist bank immediately froze the funds.
- 6. The Truist bank representative informed us that someone came to a Florida branch and showed a Sunbiz Certificate with the same business name and principal place of the S. Bower, Inc. in New York.
- 7. The Truist bank representative informed us that the depositor told the bank that S. Bower, Inc. moved from New York to Florida. This is not true.
  - 8. In fact, the Sunbiz articles of incorporation show a Patrick Glackin, residing at

510 N. 19th Street, Apt A, Fort Pierce, FL 34950 as the sole member.

- 9. Neither S. Bower, Inc. nor I have no affiliation with this individual, we do not know who he is and he does not have the authority to open a S. Bower, Inc. in Florida nor does he have the authority to open bank accounts in our name.
- 10. The Truist bank representative also informed us that the depositor gave EIN 77-0229243 that is registered to the Jame S. Bower Foundation, a non-profit company in California. We also have no affiliation with this company.
- 11. As such, S. Bower Inc., was fraudulently incorporated in Florida without the consent of any person with authority to convey the same from S. Bower Inc. in New York.

12. Accordingly, I respectfully request that S. Bower, Inc., incorporated in Florida under Document No. P23000076115 be immediately flagged as fraudulent and be dissolved.
