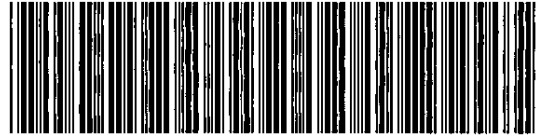



The undersigned, being the Chairman of the National Neurofibromatosis Foundation, Inc. does hereby state:


1. The name of the corporation is the National Neurofibromatosis Foundation, Inc. (the "Corporation")
2. The Certificate of Incorporation of the National Neurofibromatosis Foundation, Inc. was filed with the Department of State on March 28, 1978. The Corporation was formed under the Not-For-Profit Corporation Law of the State of New York.
3. The National Neurofibromatosis Foundation, Inc. is a Corporation as defined in subparagraph (a) (5) of Section 102 of the Not For-Profit Corporation Law and is a Type B corporation under section 201 of the Not-for-Profit Corporation Law.
4. The Certificate of Incorporation of the National Neurofibromatosis Foundation, Inc. is hereby amended to effect a change in the corporate name, pursuant to Section 801 of the Not-for-Profit Corporation Law. Paragraph 1 of the Certificate of Incorporation is hereby amended, as follows:
FIRST: The name of the proposed corporation (hereinafter the "Corporation") shall be:

5. This Amendment to the Certificate of Incorporation of the National Neurofibromatosis Foundation, Inc. was authorized by the vote, dated January 17, 2004, of a majority of the members of the entire Board of Directors of the Corporation, the affirmative Vote of which constituted a quorum.
