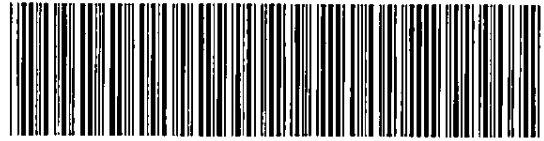

**ARTICLES OF INCORPORATION
OF
RED SNAPPER FL, INC.**

The undersigned, acting as incorporator of Red Snapper FL, Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is Red Snapper FL, Inc. (the "Corporation").

ARTICLE II. ADDRESS

The principal and mailing address of the Corporation is c/o Zahav Horizon Holdings, LLC, 218 NW 24th Street, 2nd & 3rd Floor, PMB 9647, Miami, FL 33127.

ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the Corporation will commence on the date of filing of these Articles of Incorporation.

ARTICLE IV. PURPOSE
