

# CERTIFICATE OF CORRECTION to the ARTICLES OF AMENDMENT to the ARTICLES OF INCORPORATION of WARTSILA NSD NORTH AMERICA INC.

Wartsila NSD North America Inc., a Louisiana corporation (the "Corporation"), having its registered office in the parish of New Orleans, Louisiana, hereby certifies to the Secretary of State of Louisiana that:

FIRST:

The Articles of Amendment to the Articles of Incorporation of the Corporation ("Articles of Amendment"), filed on July 8, 1997 with the Secretary of State of Louisiana, are an inaccurate record of the corporate action referred to therein. The Articles of Amendment erroneously reflect the amended name of the Corporation as "Wartsila NSD North America Inc."

SECOND:

The Articles of Amendment are hereby corrected by deleting Article FIRST of the Articles of Amendment and inserting a new Article FIRST as follows:

FIRST:

The Articles of Incorporation of the Corporation are hereby amended by deleting Article I of the Articles of Incorporation and inserting a new Article I as follows:
