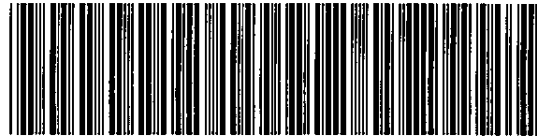

ARTICLES OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION OF  
SANDY PARK COMMUNITY CAMPUS, INC.

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment (these "Articles of Amendment") to its Articles of Incorporation ("Articles of Incorporation").

ARTICLE I

The name of the corporation is Sandy Park Community Campus, Inc.

ARTICLE II

An amendment to Article I of the Articles of Incorporation were adopted by the shareholders of the corporation effective as of January 1, 2003, for the purpose of changing the name of the corporation. Such Articles, as amended, are as follows:

1. Name. The name of the corporation is Southern Training and Educational Centers of Florida, Inc.

ARTICLE III

The number and designation of shares of the corporation outstanding at the time of the adoption of the above amendments to the Articles of Incorporation were 1000 (\_\_\_) common shares, all of which were entitled to vote on such amendments.
