Effective May 3, 2004 Harold S. Fischer resigned from North American Liability Group and its subsidiaries.

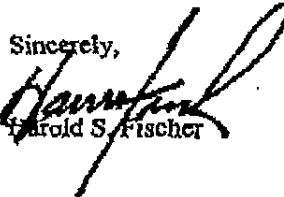
The attached letters remove Mr. Fischer's involvement in and responsibility of the company's contracts and activities. They have been notified that you are the person responsible for the company's activities.
