Dear Sirs:

I am including this with my check for the annual report of PAK'n'FAX+, Inc. I am irritated that this is the only notice that we received regarding this annual report and the associated penalty. My Spouse and VP told me we did not get any other notice but this one: You can check and see that we have always sent—it in on time since becoming a corporation in 1993. This year and last year I have been mobilized through the 711 SOS,US Air Force Reserves at Duke Field, Florida and have been deployed overseas for over 240 days since Sep 29, 2001. Most recently, I was deployed from Nov 15, 2002 to Feb 18, 2002 in support of Operations Enduring Freedom. I did not get the annual report notice in the mail through those dates. I again deployed on Apr 15, 2003 to Jun 19, 2003 in support of Operation Iraqi Freedom and I had not seen the notice before I departed. It had come in mail after returning from a brief family vacation to visit relatives and have some "Family time" with my wife and 2 boys. Normally, I have received the annual report notice and have it ready to send out in early April of every year. I feel that I am being penalized for not getting it in the mail and with the frequent deployments not adding to the situation. I would appreciate some consideration for the lack of notification and busy deployment schedule where I put myself at risk supporting the policies of the American people.
