
Gentlemen:

Please abate the late file penalties on my above listed corporations for reasonable cause.

I have operated these corporations and have always been timely on the payments of fees in past years. Last year in November 1999 I retired from the active conduct of managing the business of these six corporations, dismissed my employees, and turned the operation of these corporations over to a management company in St Cloud, Florida that operates other businesses similar to mine. We had the mail from the companies Lakeland, Florida mail boxes forwarded to the management company so they could handle the receipts and payments of the various corporations.
