INTEGRASERV, INC., a Florida corporation (the "Corporation"), hereby adopts an amendment to its Articles of Incorporation as hereinafter set forth.

1. The Board of Directors of the Corporation recommended, and the Shareholders of the Corporation adopted, in accordance with Section 607.1003 of the Florida Statutes, on July 24th, 2007, an amendment to Article V of the Articles of Incorporation of the Corporation, deleting said Article V in its entirety and substituting therefor the following:

ARTICLE V - CAPITAL STOCK

The maximum number of shares that this corporation is authorized to have issued and outstanding at any one time is 1,000,000 shares of common stock, no par value.

2. Except as modified hereby, the Articles of Incorporation of the Corporation shall be and remain in full force and effect.

3. The number of votes cast for the amendment by the shareholders was sufficient for approval, and the Corporation's shareholders are not divided into different voting groups.
