None.

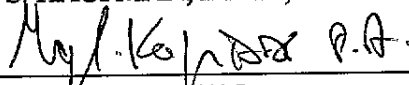
THIRD: The date of each amendment's adoption: March 7, 1996.

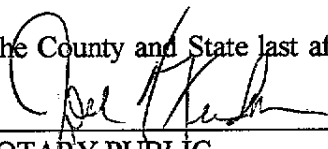
