Article I is amended to provide:

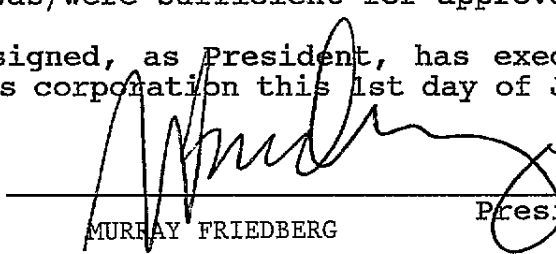
