Right of First Refusal

In the event a shareholder received a bone fide offer acceptable to him for the purchase of all or a portion of his shares (or any rights or interest therein), such shareholder (hereinefter referred to as the Offering Shareholder) shall give written notice of such offer to the Secretary of the Corporation and to all shareholders, by registered mail, at the addresses listed in the books of the corporation. The notice to the corporation shall be sent to the corporate office. The notice must not forth the name of the proposed transferse, the number of shares to be transferred, the prices per share and all other terms and conditions of the proposed transfer.

On receipt of the notice with respect to such offer, the Corporation shell have the exclusive right and option, exercisable at any time during a period of fifteen (15) days from the date of said notice, to purchase the character the corporation covered by the offer in question at the same price and on the same terms and conditions of the offer as set out in such notice.

If the Corporation decides to exercise such option, it shall give written notification of this effect to the sharsholder desiring to sell, and said sale and purchase shall be closed within thirty (30) days thereafter. If the Corporation does not slent to exercise its option to purchase any or all of the

offered shares, it shall, prior to the expiration of the fifteen (15) day paried stated above, notify the other shareholders of its election and each of the remaining shareholders shall be entitled during a period of fifteen (15) days from the date of receipt or said notice, to purchase that portion of the offered shares (not so purchased by the Corporation) that the number of shares held by him bears to the number of shares held by all shareholders electing to purchase (and actually purchasing the offered shares) on the same terms and conditions as are set out in the offer.

Each shareholder electing to purchase shall promptly give notice to the Secretary of the Corporation of the maximum number of offered shares that he is willing to purchase. If the other shareholders desire to purchase all of the shares that are subject to the offer, the Secretary shall give written notification of this effect to the offering sharsholder desiring to sell, and said sale and purchase shall be closed within thirty (30) days thereafter. In the event that the other shareholders do not intend to purchase all of the offered shares, the offering shareholder shall have the right to transfer all of the offered shares which the other chareholders do not intend to acquire to the prospective purchaser, free and clear of any rentrictions against transfer that might otherwise have been areated by this article, provided, further, that the right of the corporation to exercise its option to purchase shall be subject to the laws of the State of Florida governing the rights of a corporation to parchase its own shares.
