Pursuant to the authority of §607.1006 of the Florida Business Corporation Act, the undersigned corporation, Sriram Enterprises, Inc. (the "Corporation"), hereby adopts and files the following Articles of Amendment to its Articles of Incorporation:

(1) ARTICLE FIRST: The name of the Corporation is presently "Sriram Enterprises, Inc."

(2) ARTICLE SECOND: Article I of the Articles of Incorporation of the Corporation is hereby amended to read in its entirety as follows:

ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be JayRam, Inc.

(3) ARTICLE THIRD: The foregoing amendment to the Articles of Incorporation of the Corporation was adopted by unanimous written consent of the sole shareholder and all of the directors of the Corporation as of and effective the 18 day of December, 1998, and such consent is sufficient for approval of such amendment.
