

Pursuant to the provisions of the Florida Business Corporation Act, the Florida parent business corporation and the Domestic wholly-owned subsidiary business corporation named below do hereby submit the following Articles of Merger.

PLAN OF MERGER

OF

ABR EMPLOYER SERVICES, INC.

AND

ABR INFORMATION SERVICES, INC.

- 1. ABR Information Services, Inc., which is a business corporation of the State of Florida and is the owner of all of the outstanding shares of ABR Employer Services, Inc., which is also a business corporation of the State of Florida, hereby merges ABR Employer Services, Inc. into ABR Information Services, Inc. pursuant to the provisions of the Florida Business Corporation Act.
- 2. The separate existence of ABR Employer Services, Inc. shall cease at 11:59 p.m. on December 31, 2001 (the "Effective Time and Date of the Merger"), and ABR Information Services, Inc. shall continue its existence as the surviving corporation pursuant to the provisions of the Florida Business Corporation Act.
- 3. The issued shares of ABR Employer Services, Inc. shall not be converted in any manner, but each said share which is issued immediately prior to the Effective Time and Date of the Merger shall be surrendered and extinguished.
- 4. The Board of Directors and the proper officers of ABR Information Services, Inc. are hereby authorized, empowered, and directed to do any and all acts and things, and to make, execute, deliver, file, and/or record any and all instruments, papers, and documents which shall be or become necessary, proper, or convenient to carry out or put into effect any of the provisions of this Plan of Merger or of the merger herein provided for.
