In regard to the captioned matters, you can tell from my past filings regarding these two corporations, that we have been timely in every respect. However, in this particular case, I have called repeatedly with no return phone calls to attempt to get these returns processed in a timely fashion.

The first notice we received is in fact our two filings are "late".

Your recording states at phone number 850-488-9000, which runs through the message not one time as it suggests, or two times, but three separate times and then hangs up. I have spent an inordinate amount of time leaving messages with Secretary Harris' office directly, and was told that Director Jay Kassees runs the Division of Corporations.

Everyone needs to be fully advised that even though there are an enormous amount of phone calls that your office may receive, the recording should at least allow you to remain on the line. What it simply does is, after it presents its message, it cuts you off. I assume a number of people have had the same difficulty in getting the Division of Corporations to respond. I have had direct conversations with Matt Andrews with your office, who has informed me that he has been checking out the system as well.


