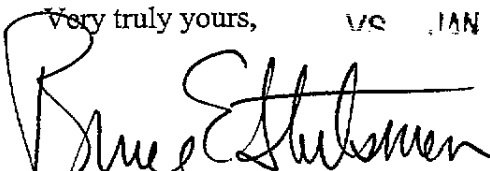

Pursuant to the Florida Business Corporation Act, Section 607.1006, the undersigned corporation does hereby adopt the following articles of amendment to its articles of incorporation:

1. The name of the corporation is Landscapes By Design Of Jacksonville, Inc. (Document Number P94000017822).

2. Article I of the Articles of Incorporation of the corporation shall be amended in its entirety to read as follows:
