To Whom it May Concern:

My name is Ivy Milian and I am the owner of Ivy Court Reporting Service, Inc. located in Miami, Florida. I first incorporated my business in April of 1994 and have been acting in the capacity of owner and president since that time. I had been at the same location of 17251 Northeast 19th Avenue until May of 1998 at which time I merged my agency with another court reporting agency located at 190 Ives Dairy Road, Suite 200, North Miami Beach, Florida, 33179. My previous address on 19th Avenue has remained unoccupied since that time although I had notified the post office of my change of address.

The agency whom I had merged with, Jessica Barman & Associates, decided to sell their agency to a company by the name of Veritext whose offices are located at 19 West Flagler Street, Miami, Florida, 33130. Because I was now a part of this other agency, I was offered a merger with Veritext and decided to accept the offer. I, once again, had a relocation of address and, in turn, had to move locations once more. This, quite possibly, is why I did not receive the first notice.

From April of 1994 through May of 1998, I have always paid my fee of \$150.00 to the Secretary of State. In fact, I have never even been late on a single payment. Despite my conscientiousness for four consecutive years, possibly due to the new location of my business and giving birth to a new baby, I somehow did not receive nor did I pay the January fee. I have collected mail from my previous address on a weekly basis and simply and truly did not receive such report from the Department of State. It is possible that since it is a vacant office, someone may have taken it out of the mailbox and thrown it away without my knowledge but I give my word that I was without receipt of this notice until I received only recently the second notice stating that I owe \$550.00 to renew.
