ARTICLES OF INCORPORATION OF

Pursuant to the provisions of Section 607.1006, Florida Statutes, SECURE SEAL OF FLORIDA, a Florida corporation incorporated on *MAY* 25, 1994, and hereinafter referred to as *Inc.* the "Corporation," adopts the following Articles of Amendment to its Articles of Incorporation:

I. Article I of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and the following is substituted therefor:

ARTICLE I

The name of the Corporation is SECURE WRAP OF MIAMI, INC. The principal place of business of this corporation shall be 3914 NW 25 Street, Miami, Florida 33142.
